

TERMS AND CONDITIONS OF ENROLMENT AT UNIVERSITY CENTRE SOMERSET (UCS), PART OF UNIVERSITY CENTRE SOMERSET COLLEGE GROUP, FOR HIGHER EDUCATION

Effective for all students accepting offers for study to commence in the Academic Year 2026/27

As a student enrolled on a Higher Education course at University Centre Somerset (UCS), part of University Centre Somerset College Group, you accept that as part of your contract with the UCS you will be bound by the following Terms and Conditions, including the policies referred to within, for the duration of your studies at the UCS.

Please note that if your course is delivered in partnership with one of UCS's University Partners you may also be required to enrol with them and your attendance will be subject to their specific Terms and Conditions in addition to UCS's. Partner Terms and Conditions can be found on the relevant Partner University's website, except for OU courses and OU Single Registerable Modules where only the UCS Terms and Conditions apply.

This document outlines the key Terms and Conditions you need to be aware of during your studies, subject to any variation or amendment which is notified to you in writing by UCS. Your course handbook(s) will contain further information relevant to your studies.

1.1 Applying to study higher education with UCS

During the application process you were provided with a range of documentation outlining the course or Single Registerable Module(s) for which you were applying. Information is also available on the UCS website about the course of study and application process, and we strongly recommend that you review this in full before accepting your offer, for further information please see:

- Information about enrolment will be sent by email from UCS's Admissions team by mid-July for those who have received an offer through UCAS; once you have an Unconditional Firm offer, further details and an on-line enrolment link will be sent mid-August.
- For those applying for Single Registerable Modules, you will receive information by email from the UCS Admissions team

1.2 Pre-contract information

Information will be made available to you prior to enrolment about the course, enrolment and central induction through a link sent by email from UCS Admissions. Key information will also be made available to those enrolling on Single Registerable Modules through a link on an email from UCS Admissions.

1.3 Accepting your offer with UCS

When accepting your offer, you will be confirming that you are aware of and have been given sufficient information about the:

- title of the course or Single Registerable Modules you are studying

- core modules/units of study for the course and any optional modules/units and any work-based commitment (optional and work-based modules/units are not available for every course)
- number of modules/units you must successfully complete to achieve your desired qualification (provided in detail in your course's handbook(s))
- potential award or grading available on successful completion of your course/Modules and who is responsible for awarding it (awards are made by the validating Awarding Organisation)
- any additional accreditation applicable to your course
- duration of the course/Single Registerable Module(s) and format of study
- location of your studies (currently all higher education courses are delivered at the Bridgwater, Taunton, Strode, and/or Cannington College of UCS as well as online). However, the UCS is at liberty to change the location of the course, as is appropriate, if there is no material interruption to the course and having given notice in writing to you of such change. There is also the possible exception of short periods out of UCS grounds for residentials and trips where feasible, in line with Government guidance from Public Health England
- cost of studying your chosen course and that you are subject to paying course fees for every year of study without any delay in making any payment against sums (if any) owed to you by the UCS. Please refer to 1.5 for further detail on payments of fees
- additional costs to your programme. Where there are additional costs to the programme, you will be made aware of these in suitable time ahead of the event or activity. Further information relating to existing additional costs in connection to your course or Single Registerable Module(s) can also be seen on your programmes page on the website and in the event of any change to additional costs, you will be notified by UCS in advance of such change
- need to provide all relevant and requested documentation to confirm your enrolment by the deadlines specified by the UCS, failure to do so may result in UCS being unable to process your enrolment and not being admitted to your course of study. This includes providing original evidence of your qualifications that your offer for entry to the programme was based on, and genuine photographic identification. Any documentation must be received by UCS by the specified deadlines and UCS cannot be held responsible for any loss suffered because of the documentation not being delivered to the correct department by the deadline date
- need to satisfactorily pass any health, welfare, fitness to study screening and criminal record checks which apply to your programme of study
- need to disclose any unspent criminal convictions to the UCS prior to enrolment on your course of study either directly to UCS or via a DBS if this is part of your course offer requirement.
- need to disclose any disability information for us to fully support you from the start and throughout your time at UCS. - need to ensure that any UK Visa and/or Immigration clearance that you are required to have to study in the UK is valid at the time that you enrol and will continue for the duration of your study. UCS may request that you provide evidence of your Visa or Immigration clearance. UCS may refuse to enrol you should you not have or are unable to provide evidence of appropriate immigration clearance. It is your responsibility to ensure that all appropriate visas are obtained, and UCS will not be responsible for any loss suffered because of failure to obtain the correct visa or clearance
- You acknowledge that the UCS has not made any statements or promises to you about the level of qualification that you will receive on completion of the course; and that the level of award that you will receive will be determined by continual assessment of your work throughout the course of study/examination against the academic grading of UCS or the University Partner (as applicable).

1.4 Assessment and Academic Regulations

You will be subject to the academic and assessment regulations of the Awarding University if your programme is approved by a University Partner, or by UCS's HE Assessment Policy if you are studying a UCS or OU validated course of study or a Pearson Higher National Diploma or Certificate. The University Partners all have regulations and policies available on their websites and UCS's documents are available on the UCS website or from the HE Team via HE@ucscollegegroup.ac.uk.

You are advised to review these in detail prior to undertaking any academic assessments.

1.5 Payment of Fees

By enrolling with UCS you are committing to UCS's HE Fees Policy for any fee related to your course and paid directly to the UCS (please note that students studying with Oxford Brookes University pay tuition fees to the University and not UCS and therefore the University's policy applies in that instance).

Subject to the maximum fee limits set out in the Access and Participation Plan 25-29 approved by the Office for Students we will review the fees and may increase them annually in line with the Retail Price Index (RPI-X).

Where a student wishes to withdraw from their course part way through the academic year for whatever reason, subject to a student observing the procedure for withdrawal, UCS will adjust the liability for tuition fees, or refund tuition fees already paid based on the following calculation:

Student withdraws		Fee liability during
Term 1	(from the first day of term 1 but before the start of term 2)	25% of full fees
Term 2	(from the first day of term 2 but before the start of term 3)	50% of full fees
Term 3	(from the first day of term 3)	Full fees

If you are enrolled on a Single Registerable Module at the point that the module starts, you will be charged for that module, even if you decide to withdraw. However, please also refer to your right to cancel in section 1.7 If you formally withdraw your application BEFORE the start of the module, you will not be charged.

If you owe fees from previous enrolments with UCS or a University Partner either from a previous course or a previous academic year, enrolment on your higher education course will be at the discretion of UCS and you may not be permitted to enrol until they have been cleared.

You cannot complete your enrolment until you have either made payment of the fees OR you have evidence, to the satisfaction of UCS, of payment in place such as:

- a student loan or payment by a sponsor (such as your employer)
- fees may be made in instalments, but this is at the discretion of UCS. International students will be required to pay fees in full.
- failure to pay fees may result in UCS withholding your final award certificate, and
- except where the course is cancelled because of matters referred to in 2.2, if UCS cancels your course you will be eligible for a refund.

1.6 Student Accommodation

If you are offered a place in our Student Accommodation you will need to make yourself aware of the Accommodation Agreement and always comply with its terms. Failure to comply with the UCS's Accommodation Agreement may result in suspension or exclusion from your course. If you are suspended or excluded because of a breach of the Accommodation Agreement, UCS will not be liable for any loss incurred by you. 1.7 Right to Cancel

If you accept a place on a full course (rather than Single Registerable Module(s)) and you decide, within the first 14 days of accepting your offer, that you wish to withdraw, you may do so without any penalty. Information about how to withdraw an offer acceptance can be found on UCAS at:

If, however, you enrol for your full course (i.e. for 120 credits or more) and then change your mind, you have the right to cancel within 14 days from the date of enrolment without giving us any reason. A student who permanently withdraws in the first 14 days after enrolment on a full course (i.e. for 120 credits or more), will not be held liable for any tuition fees for that academic year.

As stated in section 1.5, students enrolling on Single Registerable Modules may withdraw their application without being liable for a charge until the start of the Module. For the avoidance of doubt, students on Single Registerable Modules do NOT have a 14-day cancellation/cooling off period once the module starts.

For those on full courses of 120 credits or more, if after 14 days have lapsed, you decide to cancel the contract for any reason other than a material breach of these Terms and Conditions by UCS, you will be liable to UCS's HE Fees Policy as summarised in 1.5. If you are enrolled with Oxford Brookes University you will be subject to their Fees Policy and should consult their website for further information on this via <http://www.brookes.ac.uk/studying-at-brookes/finance/>

If you decide to withdraw after the 14-day cancellation period you may do so at any time, but your withdrawal must:

- be made by emailing your Course Leader
- include a reason for withdrawing
- details of whether the withdrawal is permanent or temporary.

If you withdraw and you have completed assessments during the year and achieve some credit or an exit award this will be considered by the relevant Award Board (or equivalent) at the end of the academic year, you will be notified of the outcome but will not be eligible to attend graduation.

UCS may terminate the contract, at any time in writing to you if you are in material breach of these Terms and Conditions or any of the policies referred to and UCS will not be liable to you for any loss suffered because of such termination.

Nothing in these terms will exclude or limit UCS's liability for death or personal injury caused by UCS's own negligence.

1.8 Student Conduct

You are expected to conduct yourself appropriately whilst studying at UCS and adhere with UCS's Professional Expectations and any policies referred to in it. Inappropriate behaviour that results in UCS exercising its Positive Behaviour Policy & Behaviour Management Procedure to the final stage may result in UCS withdrawing you from your programme of study, resulting in payment of fees in accordance with the withdrawal information outlined in section 1.5 above. UCS's Professional Expectations detail how UCS expects you to conduct yourself whilst studying here. 1.9 Complaints

You have the right to complain about any aspect of your experience as a higher education student at UCS at any time. It is hoped that informal complaints can be resolved quickly and effectively. If you wish to lodge a complaint you need to be aware that UCS has a UCS HE Complaints Policy. If further to your complaint UCS or your Awarding Organisation have provided you with a "Completions of Procedures" (CoP) letter and you are still unhappy with the outcome, you may be able to refer it to the Office of the Independent Adjudicator. If you have made a complaint to UCS in respect of the delivery of the course/Single Registerable Module(s) or otherwise, this will not permit you to suspend payments due to UCS pending the outcome of the complaint, you will still be liable for UCS's fees.

2.0 Academic Appeals

You can only formally appeal your marks/grades once they have been confirmed by UCS's Award Board (or equivalent) at the end of a semester or academic year. If you are affiliated to a University Partner, you must always use their academic appeals policy from the outset. If you are on a UCS, OU-validated course or Higher National Diploma or Certificate validated by Pearson, you must use UCS's HE Academic Appeals policy and procedure, available on the UCS website <https://www.somerset.ac.uk/about/policies/regulations/university-centre-somerset/> or by contacting the HE Team via HE@ucscollegegroup.ac.uk

There is a time limit on the period between receiving your results and being able to lodge an academic appeal, you should be aware of this, and details will be contained within the appeals procedure relevant to you. University Partner appeals procedures are located on their websites and links are available within your course handbooks. 2.1 Changes to the content and/or structure of your course

UCS has used reasonable endeavours to ensure the content of the prospectus and website is correct and accurate. However, there are occasions where the course structure or module content may vary from what was originally advertised which may be due to changes in the commissioning or accrediting body, approval with the University Partner or other operational variations that impact upon it and UCS may be required to make reasonable adjustments to the course or module. These changes are outside of the control of UCS, and UCS will not be liable for any loss suffered because of such changes.

UCS will always seek to minimise any changes to a programme of study, however where those changes are significant and impact materially on the content and delivery of the course of study, you will have the option and right to in the first instance transfer to an alternative course of study (if appropriate) or to cease studying on that programme without penalty. Any fees paid up to the date of the change in the course will be retained by UCS as payment of the services rendered.

Major changes will be managed via an approval procedure both internally and with the Partner University/Awarding Organisation. If there are changes, UCS will notify you of the changes.

2.2 Attendance Agreement

UCS is committed to providing a supportive learning environment which enables you to achieve your full potential.

As a responsible institution, UCS has a duty to monitor attendance, and to act on non-attendance so that you can be supported to successfully complete your programme of study.

UCS is required to monitor your attendance and provide a termly report to Student Finance England.

1. UCS expects you to attend all timetabled classes. It is in your own interest that you attend all timetabled classes; it will help you achieve successful results. Please arrive on time for classes as late arrival causes disruption to other class members and your tutor.
2. Please notify your module tutors and personal tutor in advance (by email, Teams, or phone) if you expect to be absent from timetabled sessions. You will need to decide to catch up on any work missed during absence.

3. Please avoid taking holidays during term-time; this includes the weeks leading up to the end of the academic year.
4. We recognise that there are occasions where students have difficulties attending classes because of personal, financial, or academic problems. If so, please talk to your Tutor at the earliest stage.
5. A poor attendance record could result in the following:
 - Maintenance loans/grants payments being withheld
 - UCS informing the Student Loan Company and the UK Visas and Immigration as applicable. Failure to attend could therefore impact on the funding available and/or your ability to remain in the country
 - you may be withdrawn from the programme and still incur costs as outlined in section 1.5 above.
6. If you are absent for two consecutive weeks, without prior notification, your Tutor may invite you to attend a tutorial meeting.
7. Where there is unexplained absence of more than four weeks, we may start the process to withdraw or suspend you from the programme of study. This action will be reported to the Award Board for ratification.
8. Regular absence by a student, including for short periods of time, may also trigger intervention by the Programme Team and could lead to a suspension or discontinuation of studies.

2.3 Unforeseen Circumstances

UCS will not be liable to you for any loss suffered because of events that happen outside of our control. These events include industrial action, staff illness, terrorist attacks, political unrest, changes to research practices, or changes by the accrediting body. In such circumstances we reserve the right to change or cancel parts of your programme to ensure UCS continues to provide a high standard of provision.

2.4 Data Protection Act 2018

UCS will hold and process your data for its own administrative purposes in accordance with its Data Protection Policy and Procedure. You must ensure you inform UCS of any changes to your personal information throughout your time at UCS.

UCS will communicate with you via your personal UCS email address. Your University Partner (if applicable) will also do this via their email system. Please ensure you check these regularly, UCS cannot be held responsible for any loss arising because of your failure to do so.

2.5 Order of Precedence

In addition to these Terms and Conditions, you are also subject to the policies referred to and any other relevant UCS policies relating to how you use facilities, resources, and academic practise, and must abide by these for the duration of your studies. Relevant policies are available to you on the UCS website. You should familiarise yourself with these prior to enrolment. 2.6 Law and Jurisdiction

These terms and conditions shall be governed by the laws of England and Wales and subject to the exclusive jurisdiction of the English courts.
